By strengthening alert mechanisms, such as incident reporting and helplines, children and adolescents were able to access timely preventive and response child protection services, for instance family preservation, social welfare, referral services, and information. Through vulnerability assessment, which is integrated into Child Protection programming, the programming was able to reach 6,254 of the most vulnerable and marginalized children with services. In both emergency and humanitarian situations, it has aided the early identification of children and adolescents at risk of violence, abuse, and exploitation.
