In 2022, UNICEF supported national and provincial coordination for multisectoral nutrition and child development programming and humanitarian response. UNICEF continued strengthening the Scaling Up Nutrition Movement (SUN) coordination platforms at MoPDSI and Provincial Development (PDD) for functional multisectoral coordination, advocacy for public financing for nutrition and integration of nutrition with the key sectors, mainly the health, strengthening nutrition information system. Following the 2022 monsoon flooding, UNICEF co-led the nutrition sectors at national and provincial levels for the emergency nutrition response and launched Flash Appeal and revision of Humanitarian Action for Children (HAC).
