Technical guidance and support from UNICEF contributed towards the development of agency-specific protocols on handling Children in Situations of Armed Conflict, for the Department of Education, Department of Health, and Department of Social Welfare and Development. The National Child Protection Working Group (NCPWG), with support from UNICEF, worked towards the integration of the national CFS guidelines into the cluster guidelines of the Camp Coordination and Camp Management, and as a criterion for Seal of Good Local Governance. To date, all 17 RCPWG are functional, with varying degrees of capacity and readiness to support subnational humanitarian initiatives for child protection.
